- D. The complete transcript of the digital recording of the Telephone Status Conference held by the Honorable Judge Juanita Rice on October 11, 2006 at approximately 4:30 pm. Respondent believes Judge Rice made a digital recording of the Telephone Status Conference and had a transcript of the Telephone Status Conference transcribed and prepared for the judge's use in her judgments.
- E. The CD Rom submitted with Respondent's "Verified Transcript Of Telephone Conference Held On October 11, 2006" (Exhibit 2) that was attached to Respondent's Motion For Ruling On Motion For Post Trial Relief filed on July 6, 2007.
- F.
